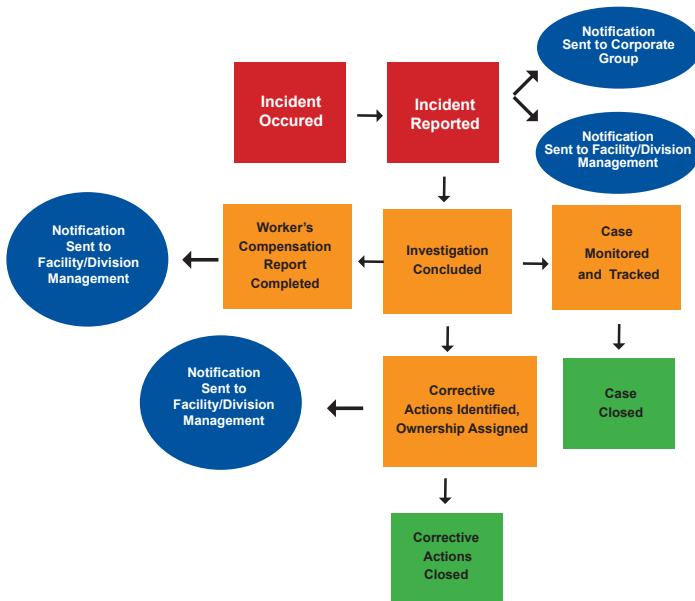
Visibility: Facilities can instantly record the essential information for an accident or incident. Corporate staff are quickly aware of, and can track, all accidents and incidents company-wide.
